## Sharyland North Junior High Parent and Family Engagement Policy ESSA Section 1116 2022-2023

#### **Mission Statement**

Sharyland North Junior High's mission is to inspire, educate and empower all students to reach their full potential and become leaders of the highest moral character.

## **Statement of Purpose**

Sharyland North Junior High provides quality education for every student on our campus. To accomplish this objective, Sharyland North Junior High will develop and maintain partnerships with parents/caregivers, patrons, and community members. Through this united effort, students become more successful and productive citizens.

### **Program Requirements and Implementation**

**Sharyland North Junior High** agrees to implement the following statutory requirements:

1. Jointly develop with, and distribute to, parents and family members of participating students a written Parent and Family Engagement (PFE) policy, agreed on by such parents, that will describe the means for carrying out the requirements of ESSA (Every Student Succeeds Act) Section 1116 subsections (c) through (f).   - The campus Parental and Community Liaison is responsible for conducting such meetings and might include a member of administration, such as, but not limited to school principal, assistant principal, counselor.

- Such meetings are usually held during the evening hours, when it is convenient for most parents.
- 4. - o Continue parent and family engagement via the Sharyland Parent-Teacher-Student Organization (SPTSO), the Site-Based District Committee (SBDC), and the Language Proficiency Assessment Committee (LPAC)
- o The review and improvement of the policy is based on parent participation during the annual meeting, which is held in-person based on parent convenience.
- 5. Provide parents of participating children
  - A. timely information about programs under this part;
  - B. a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and C. if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their student, and respond to any such suggestions as soon as practically possible.
  - o Parents are informed about the Parent and Family Engagement program and activities through SPTSO, Open House nights, and communication avenues such as, but not limited
  - to, Remind, parent newsletters, Skylert, Meet the Teacher Night, social media, Google Classroom, school's Parent webpage.
  - Some of the program activities include monthly meetings, such as Technology Tuesdays and the Parent Institute hosted by the district.
  - o Other activities include virtual and in-person meetings to discuss technology, social media, school platforms; parenting classes such as stress management, decision- making skills.
- 6. If the schoolwide program plan (Campus Improvement Plan, CIP) under section 1114(b) is not satisfactory to the parents of participating students, submit any parent/guardian comments on the plan when the school makes the plan available to the local educational agency.

  - ii.provide materials and training to help parents to work with their student to improve their achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parental involvement; for example, share with parents resources on how to access and use important digital/platforms through our district and campus websites and meetings; provide parents information related to educational software and websites our students use; and promote district ESL classes and/or classes offered

through Region One and through our district and campus;

- iii.educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school; for example, seek recommendations from parents, ask parents to share their testimonials, and utilize parent feedback to impact planning and decision-making at campus level;
